EMPANELMENT OF RETIRED/RETIRING OFFICERS OF HIMACHAL PRADESH GRAMIN BANK AS WELL AS OF OTHER NATIONALIZED BANKS FOR CONCURRENT AUDIT ASSIGNMENT

1. HPGB invites applications from Retired/Retiring Officers of Himachal Pradesh Gramin Bank as well as of other Nationalized Bank, who fulfill the eligibility criteria as mentioned here under and have honorably retired upto **31.03.2026** with satisfactory service record, for empanelment as Concurrent Auditor.
2. The Bio-data should be submitted **on the attached format** to the General Manager, Inspection & Audit Division, HPGB Head office –VPO- Gutkar –Mandi only **by postal service/courier** or by email at '**hoinspectionhpgb@hpgb.bank.in**' **latest by 15.07.2026 up to 5 PM.**
3. "Application for **"Empanelment of Concurrent Auditor"** should be mentioned on the envelope, carrying Bio-data.
4. Mere submission of application for empanelment or approval of the name for empanelment does not, in any way, constitute guarantee for allotment of the audit job of any nature from the bank. The allocation of branches to the auditors is the prerogative of the Bank.
5. It is only a contractual work for a specific period and the Retired Officer/s so assigned the work is not entitled to claim any regular employment or any other benefit in the bank in future.

Eligibility Criteria:

Concerned retired official must have:

- i) Retired honorably from our Bank as well as from other Nationalized Bank, in either MMG Scale II or above. The officers voluntarily retired/ resigned/ suspended/ dismissed/removed from Bank's services shall not be eligible for the purpose.
- ii) An experience of minimum of 20 years' service in our Bank/other Nationalized Bank with a satisfactory track record.
- iii) Branch experience of 10 years as an officer.
- iv) Worked either as an Incumbent In-charge for a period of minimum 2 years and/ or Handled credit portfolio of a branch as an officer for a period of 2 years.
- v) No major penalty imposed by the Bank during the entire service period or no minor penalty imposed by the Bank during the last five years of service (subject to verification from available

HRMS record & self- certification by the concerned retired officer.

Vi) A retired Official will be on cooling period for at **least six (6)** months from the date of his / her retirement before becoming eligible for getting an audit assignment, even though he / she may already be on the panel for Concurrent Audit in the Bank. However, subject to availability of empaneled retired officials at a place and bank's requirement, this cooling period **be relaxed to 3 months**. Head of internal audit shall be the competent authority for such relaxation.

VII) The ERO will be immediately debarred if found indulged in other activities, financial / intermediary activities with the Bank during their period of audit assignment.

VIII) Fresh Concurrent Audit assignment may be given to a Retired Staff of our own Bank or other Nationalized Bank up to the **age of 67 years or completion of last audit assignment**, whichever is later.

IX) A sound health i.e. he/she must be medically fit to carry out the assignment of concurrent audit (A certificate from a MBBS Doctor be submitted).

7. Terms & Conditions:

i) The tenure of the concurrent audit would be initially for **THREE** years and would be extended for a further period of **TWO** years (overall **FIVE** years), based on the performance of the auditor in the first year.

ii) Assignment will be subject to review on Quarterly basis as on the last day of March, June, Sept. & December by **General Manager (Inspection)** Head Office – Mandi

iii) In case of unsatisfactory performance for 2 consecutive quarters, the assignment will be cancelled, even before completion of the period of assignment. **Chairman** will be the competent authority for such cancellation.

iv) Retired **Staff of OWN BANK or other Nationalized Bank appointed** as auditor will carry out the concurrent audit related activities including verification of security as per bank norms.

v) The eligible retired staff of OWN BANK or other Nationalized Bank appointed as auditor will be given audit assignment of **maximum 3 branches plus (Head Office (wherever applicable))**

vi) Operational guidelines will be handed over to the selected Retired Officer, at the time of handing over the assignment.

vii) The Retired Officer who is so selected for the assignment should attend the Office/ Branch allotted on all working days and should be present in the branch during the working hours.

viii) Only two days' leave will be allowed to the Concurrent Auditors during the month, over and

above including leaves shall be treated as without pay.

ix) Non-attendance of office/branch shall also be treated as without pay & without prior permission he will not left the office for a long period.

8. Fee payable/Expenditure Involved:

i) The criteria of total business & monthly fee payable to such Retired Officials is as under subject to deduction of Income Tax at source, if any.:

Total Business	Fee payable (per month)
Branches having business up to Rs.300 crore	Rs.15,000/-per branch

viii) In case of concurrent audit of more than one branch, **Rs.3000/-** per month (reimbursement of conveyance charges shall be maximum extent to the days of earned professional fees @ the Rs. 100/- per day) shall be paid as conveyance, which would be over & above the above remuneration.

9. The Retired Official will undertake that he/she will not sub-contract /sub-assign the audit assignment.

10. Incomplete application or application without requisite enclosures will not be entertained.
